Tuition assistance will be first granted to families for the 9am-12pm session and for full day preK and not for auxiliary. Should we have money left over after awarding grants for the primary school day, we will award funding for auxiliary programming.

- A copy of the filed **2021** federal tax return Form 1040
- A copy of your **2022** W-2s

Should you expect your family's financial situation for the 2023-2024 school year to be substantially different than what is presented in your 2021 taxes or your 2022 income documents, please use the space provided at the end of the application to explain.

Completed tuition assistance applications must be submitted to PCCH no later than February 28. In order to assure consideration for the upcoming school year. Applications received after this deadline will be subject to availability of funds. You may mail your documentation in or may hand it, in a sealed envelope, to an administrator at drop off.
